Experience

Massive natural resource litigation involving land owners and property damage as a result of a flood We were able to negotiate a reasonable settlement for our client, a land holding company, in a massive litigation case. Over 3,000 plaintiffs – primarily property owners – sued land holding companies in Southern West Virginia who helped provide natural resources in the area. The suit claimed the land use, in terms of natural resource extraction, caused peak flow of water to increase resulting in the flooding and an overall change in the terrain of the land causing increased flooding. This case went on for ten years, and was one of the largest litigated cases in West Virginia history.
